

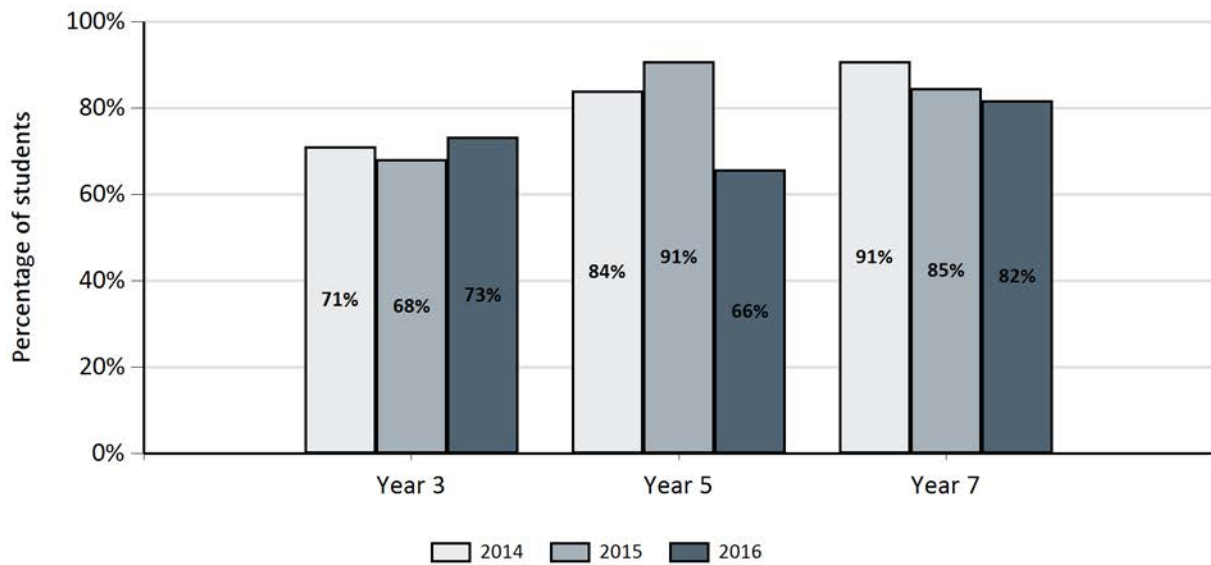

NAPLAN Proficiency

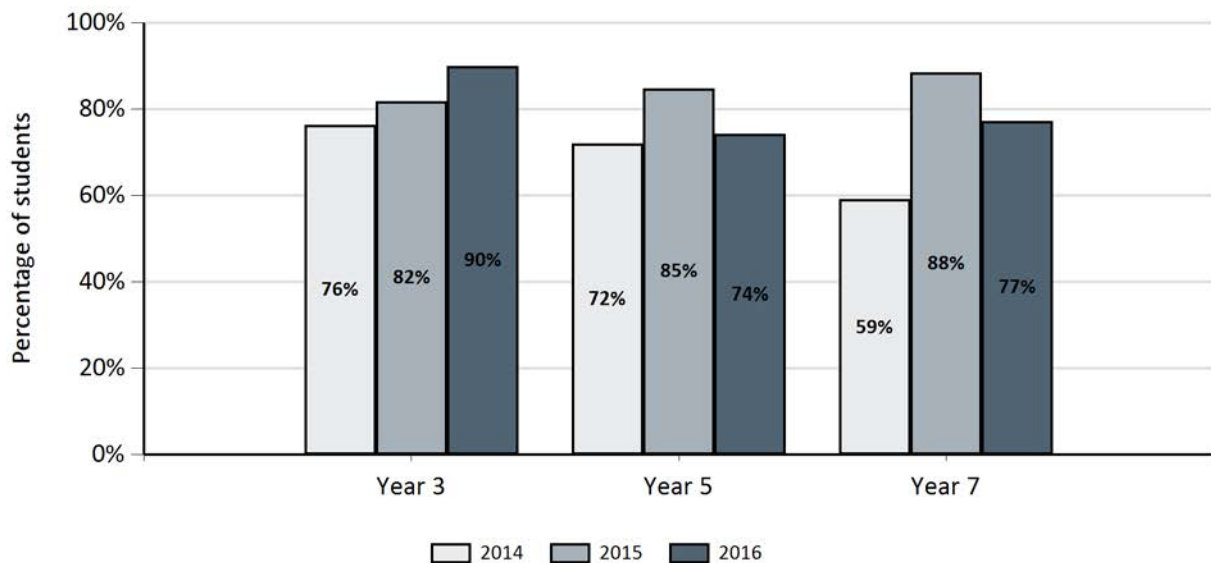
